## Economic and Community Development - Community Technology Centers

- 3 FOR the purpose of establishing the Community Technology Center Program in the Department of Business and Economic Development to provide grants to certain 4 5 nonprofit organizations for the development of information technology training 6 and support in certain communities; establishing eligibility criteria for grant 7 recipients; establishing a limit on the grant amount; requiring the Department 8 to adopt regulations to carry out the Program; requiring the Department to 9 submit a certain report to the Senate Finance Committee and the House 10 Economic Matters Committee on or before a certain date; establishing the intent of the General Assembly regarding funding for the Program; defining a 11 certain term; and generally relating to the Community Technology Center 12 Program. 13
