## Certified Social Workers-Clinical - Practice - Definition 2

- 3 FOR the purpose of altering the definition of "practice social work" so as to authorize a licensed certified social worker-clinical to practice social work by evaluating, 4 5 diagnosing, and treating certain mental and emotional conditions and impairments in addition to certain other conditions and disorders; and generally 6 relating to defining the practice of social work for certified social 7 workers-clinical. 8
