# 2 Vehicle Laws - Exceptional Milk Hauling Permit - Raw Liquid Milk

3 FOR the purpose of authorizing the State Highway Administration to issue an 4 exceptional milk hauling permit valid in certain counties for a combination of 5 vehicles <del>or a straight truck</del> that carries certain raw liquid milk to a processing 6 plant and has an axle configuration that meets certain requirements; requiring 7 a combination of vehicles <del>or a straight truck</del> operating under the authority of an 8 exceptional milk hauling permit to comply with certain weight limits; requiring 9 a certain combination of vehicles or straight truck, twice each year, to submit to 10 and pass a certain inspection and be allowed only a certain load limit tolerance; prohibiting a person who operates a certain combination of vehicles or straight 11 truck from violating certain highway restrictions, operating the combination of 12 vehicles on an interstate highway system, or operating the vehicle if it exceeds 13 certain ratings or restrictions or fails to comply with the terms and conditions of 14 15 the permit; requiring a person who operates a certain combination of vehicles <del>or</del> 16 straight truck to have, in the person's possession, a certain permit and certain 17 inspection reports; specifying the penalties for the violation of certain provisions of law, regulations, or the terms and conditions of certain exceptional milk 18 19 hauling permits; authorizing the revocation of an exceptional milk hauling permit under certain circumstances; authorizing a certain person to appeal the 20

1 revocation of an exceptional milk hauling permit; requiring certain records to be 2 provided to the State Highway Administrator or the Administrator's designee 3 on request; authorizing the State Highway Administrator to take certain action 4 if certain records are not received; establishing certain fees; providing that an 5 exceptional milk hauling permit is valid for a certain period; requiring the State Highway Administration, in consultation with the Secretary of State Police, to 6 7 adopt certain regulations; requiring the State Highway Administration and the 8 Department of State Police to submit a certain report on or before a certain date: establishing that the issuance of a permit under this Act is at the 9 10 discretion of the State Highway Administrator; requiring the State Highway Administrator to report a certain decision to the General Assembly; providing 11 for the construction of this Act; providing for the termination of this Act; and 12 13 generally relating to vehicle size, weight, and load limits, and exceptional milk 14 hauling permits.

SECTION 2. AND BE IT FURTHER ENACTED, That the State Highway 24 Administration, in conjunction with the Department of State Police, shall report to the 25 General Assembly on or before December 1, 2009, in accordance with § 2–1246 of the 26 27 State Government Article, on the use and enforcement of exceptional hauling permits,

including compliance with this Act, regulations adopted to implement this Act, and the

terms and conditions of exceptional hauling permits.

SECTION 3. AND BE IT FURTHER ENACTED, That the issuance of permits 1 2 under this Act is at the discretion of the State Highway Administrator. The State 3 Highway Administrator may stop issuing and renewing permits under this Act if the 4 Administrator determines that the use of exceptional milk hauling permits is adversely affecting any part of the State highway system. The State Highway 5 Administrator shall promptly report to the General Assembly, in accordance with § 6 7 2-1246 of the State Government Article, regarding any decision to stop issuing or 8 renewing permits under this Act and the reason for the decision.

9 <u>SECTION 4. AND BE IT FURTHER ENACTED, That nothing in this Act shall</u> 10 <u>be construed to exempt a holder of an exceptional milk hauling permit from any</u> 11 <u>applicable State or federal motor carrier requirements not specifically addressed in</u> 12 <u>this Act.</u>

13 SECTION 4. 5. AND BE IT FURTHER ENACTED, That this Act shall take 14 effect October 1, 2007. It shall remain effective for a period of 4 years and, at the end 15 of September 30, 2011, with no further action required by the General Assembly, this 16 Act shall be abregated and of no further force and effect
