Health Occupations - Morticians - Exemption and Permit Funeral Director Licenses

4 FOR the purpose of providing that certain licensing requirements for practicing 5 mortuary science do not limit the Maryland State Board of Morticians from issuing a permit to certain designees to handle, transport, and work with a dead 6 7 human body in performing certain religious services without a mortician's license; subjecting certain designees to conditions and limitations the Board 8 9 may specify; requiring the Board to adopt certain regulations; requiring the Board to submit a certain report on or before a certain date; exempting certain 10 apprentices from assisting with embalming if a certain affidavit is submitted to 11 the Board; providing for the termination of certain provisions of this Act; and 12 generally relating to exceptions to the Maryland Morticians Act renaming the 13 14 State Board of Morticians to be the State Board of Morticians and Funeral Directors: requiring that an individual be licensed by the Board before the 15 16 individual may practice funeral direction in this State; requiring the Board to 17 establish certain gualifications, examinations, and experience requirements for licensing funeral directors; requiring that certain practical examinations, 18 competency demonstrations, and practical experience do not include embalming; 19 requiring that applicants for certain apprentice licenses have certain sponsors; 20
