- 24 (3) (i) A procurement by a University shall comply with the 25 policies and procedures developed by the University and approved by the Board of 26 Public Works and the Administrative, Executive, and Legislative Review Committee of 27 the General Assembly in accordance with § 12–112 of the Education Article for the 28 University System of Maryland, § 14–109 of the Education Article for Morgan State 29 University, or § 14–405(f) of the Education Article for St. Mary's College of Maryland.
- 30 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 31 June 1, 2007.
