## A BILL ENTITLED

1 AN ACT concerning

2 **Delmarva Advisory Council - Repeal**

3 FOR the purpose of repealing provisions of law establishing Maryland's membership  
4 on the Delmarva Advisory Council; eliminating the representative of the  
5 Delmarva Advisory Council from the membership of the Executive Board of the  
6 Rural Maryland Council; requiring the Department of Legislative Services to  
7 provide certain notice of the enactment of this Act; and generally relating to the  
8 Delmarva Advisory Council.

3           SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
4 MARYLAND, That Section(s) 1–101 through 1–111 and the article “Article 32B.  
5 Delmarva Advisory Council” of the Annotated Code of Maryland be repealed.

6           SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland  
7 read as follows:

8           **Article 41 – Governor – Executive and Administrative Departments**

9           15–104.

10           (c)   (2)   The Executive Board shall include:

11                           [(xii) One representative of the Delmarva Advisory Council;]

          SECTION 3. AND BE IT FURTHER ENACTED, That Section(s)  
15–104(c)(2)(xiii) through (xxvii), respectively, of Article 41 of the Annotated Code of  
Maryland be renumbered to be Section(s) 15–104(c)(2)(xii) through (xxvi), respectively.

12           SECTION 4. AND BE IT FURTHER ENACTED, That the Department of  
13 Legislative Services shall notify the appropriate officials of the State of Delaware and  
14 the Commonwealth of Virginia of the enactment of this Act.

15           SECTION 5. AND BE IT FURTHER ENACTED, That this Act shall take effect  
16 October 1, 2007.
