FOR the purpose of including Dorchester County in the list of counties in which the
sheriff may appoint as deputy sheriffs certain members of certain fire
companies to exercise the powers of deputy sheriffs at fires and while going to
and from fires and appoint as deputy sheriffs certain members of certain fire
companies to exercise the powers of deputy sheriffs at certain events; and
generally relating to the appointment of members of fire companies as deputy
sheriffs in Dorchester County.

- 21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 22 MARYLAND, That the Laws of Maryland read as follows:

8 9 10 11	(b) The sheriff of a county subject to this section may appoint as deputy sheriffs members of fire companies, whether volunteer, career, incorporated, or unincorporated, to exercise the powers of deputy sheriffs at fires and while going to and from fires.

26 27 28	(2) The powers of members appointed as deputy sheriffs do not apply and may not be exercised in a municipal corporation that maintains an organized police force.

27 28 29	(a) (1) This section applies only to Allegany County, Carroll County, Cecil County, DORCHESTER COUNTY, Frederick County, Harford County, Kent County, Somerset County, Wicomico County, and Worcester County.			

1 (2) Except as modified by this section, the provisions of § 7–302 of this 2 subtitle apply to this section.

3 (b) (1) Except as provided in paragraph (2) of this subsection, the 4 commanding officer may designate 12 members of a fire company to be appointed as 5 deputy sheriffs.

6 (2) In Cecil County, the commanding officer may designate 20 7 members of a fire company to be appointed as deputy sheriffs.

8 (c) (1) The sheriff of a county subject to this section may require a 9 member of a fire company appointed as deputy sheriff to demonstrate a satisfactory 10 level of training in those areas of law enforcement commensurate with the duties of 11 deputy sheriff described in this section.

12 (2) If the sheriff requires demonstration of a satisfactory level of 13 training, then the sheriff must provide the training, at a time and place that the 14 sheriff considers suitable.

15 (d) (1) The powers of members of fire companies appointed as deputy 16 sheriffs under this section are limited to those necessary to perform the duties of 17 deputy sheriffs while functioning at:

- 18 (i) parades;
- 19 (ii) accidents;
- 20 (iii) floods;
- 21 (iv) other emergencies; or
- (v) public events conducted by or under the auspices of a fire
 company or the sheriff's department.
- 24 (2) The powers authorized under this subsection may be exercised:
- (i) in a municipal corporation, subject to the discretion and
 control of the chief of the police force of the municipal corporation;
- 27 (ii) in other areas of the county; and

1 (iii) on State roads, subject to the discretion and control of the 2 Department of State Police.

3 (3) A member appointed as deputy sheriff is deemed to be performing 4 the duties of deputy sheriff when on duty and wearing a badge of authority.

5 6 (4) A member appointed as deputy sheriff may not use a weapon in the performance of duties authorized under this subsection.

7 (5) In Allegany County, Carroll County, Frederick County, and 8 Harford County, a member appointed as deputy sheriff may also perform traffic 9 control for public functions held by a municipal corporation, group, or committee on 10 request for and approval of the services by the sheriff.

11 (e) (1) (i) A member appointed as deputy sheriff performing the duties 12 of deputy sheriff in an emergency situation to which a fire company or ambulance 13 company has been dispatched by the Allegany County Emergency Management Center 14 in Allegany County, the Frederick County Central Alarm Board in Frederick County, 15 or the Carroll County Emergency Operations Center in Carroll County, is subject to 16 the authority of the commanding officer of that fire company or ambulance company.

(ii) If a member appointed as deputy sheriff is not a member in
good standing of the fire company or ambulance company that has been dispatched,
then the member may not perform the duties described in this section.

20 (2) A member appointed as deputy sheriff performing the duties of 21 deputy sheriff at a public event conducted by or under the auspices of a fire company 22 or ambulance company is subject to the authority of the commanding officer of that 23 fire company or ambulance company.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 October 1, 2007.
