1 AN ACT concerning

2 **Prince George's County - Property Tax Credit -**
3 **Kettering-Largo-Mitchellville Boys and Girls Club**

4 FOR the purpose of requiring the governing body of Prince George's County to grant a
5 property tax credit against the county property tax imposed on real property
6 that is owned by the Kettering-Largo-Mitchellville Boys and Girls Club;
7 providing for the application of this Act; and generally relating to a county
8 property tax credit for property in Prince George's County owned by the
9 Kettering-Largo-Mitchellville Boys and Girls Club.

10 BY repealing and reenacting, with amendments,

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article - Tax - Property**

2 (a) The governing body of Prince George's County shall grant a property tax
3 credit under this section against the county property tax imposed on:

4 (1) real property:

5 (i) owned by the Maryland Jaycees, Incorporated; and

6 (ii) used in the operation of a charitable nonprofit educational or
7 rehabilitation institution of the kind that is exempted under § 7-202 of this article;
8 [and]

9 (2) real property owned by the Prince George's County Chamber of
10 Commerce Foundation, Inc., if the real property:

11 (i) is acquired on or after November 24, 1973; and

12 (ii) is not used for a commercial purpose; **AND**

13 **(3) REAL PROPERTY OWNED BY THE**
14 **KETTERING-LARGO-MITCHELLVILLE BOYS AND GIRLS CLUB.**

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 June 1, 2007, and shall be applicable to all taxable years beginning after June 30,
17 2007.
