- 4 FOR the purpose of altering the annual salaries of the chairman and other members of 5 the Board of License Commissioners of Anne Arundel County; altering the annual salaries and monthly expenses of the part-time chief inspector and 6 7 part-time inspectors of the Board; altering the annual salary of the attorney for 8 the Board; authorizing the Board to increase the number of part-time 9 inspectors; providing that this Act does not apply to the salary or compensation 10 of the incumbent chairman or other members of the Board; and generally relating to the members and employees of the Board of License Commissioners 11 12 of Anne Arundel County.

- 1 In Anne Arundel County the chairman of the Board of License (c) 2 Commissioners shall receive annually as salary not more than [\$15,000] **\$18,000**: 3 each other member of the Board shall receive annually as salaries not more than [\$8,500] **\$15,000**, plus reimbursement for expenses reasonably incurred by them. 4 5 15–112. 6 This subsection applies only in Anne Arundel County. Except for (c) (1) 7 paragraph (2) of this subsection, it does not apply in the City of Annapolis. 8 (2)(i) This paragraph applies only in the City of Annapolis. 9 The Mayor, Counselor and Aldermen of Annapolis may (ii) make and enforce regulations and restrictions, in addition to, or in substitution of, 10 those contained in this article, but not inconsistent therewith, as in their judgment 11 would give the municipality more effective control of each of the places of business. 12 13 In addition to the powers given to the Board in subsection (a) of this section, the Board may employ one part-time chief inspector at an annual salary 14 15 of [\$8,000] **\$10,000**, and [16] **19** part–time inspectors at an annual salary of [\$5,000] **\$6,000** each. In addition to this salary, each of the inspectors shall receive a monthly 16 expense of [\$150] \$300 per month, subject to the approval of the State Comptroller. 17 (4) The [17] **20** inspectors shall: 18 19 Have all the powers of a peace officer or a constable or 20 sheriff of this State; 21 Make oath to faithfully perform the duties entrusted to (ii) them, as provided in Article I, § 9 of the Constitution of this State; and 22 23 Furnish bond in the penalty of \$2,000 to the Board and the (iii) 24 County Council jointly, conditioned "that inspector shall well and faithfully execute 25 the office in all things appertaining thereto". The cost of the bond shall be paid by the 26 county. The inspectors for Anne Arundel County are known as the "liquor inspectors for Anne Arundel County". 27 The Board of License Commissioners: 28 (5)
- 29 (i) May employ up to two full-time administrators whose 30 annual salaries shall be fixed by the Board as in a general Anne Arundel County 31 classified salary schedule, within pay grade 16;

3	pay grade 13; and

6	SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, §
7	35 of the Maryland Constitution, this Act may not be construed to extend or apply to
8	the salary or compensation of the chairman and other members of the Board of
9	License Commissioners of Anne Arundel County in office on the effective date of this
10	Act, but the provisions of this Act concerning the salary or compensation of the
11	chairman and other members of the Board of License Commissioners of Anne Arundel
12	County shall take effect at the beginning of the next following term of office.
13	SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
14	July 1, 2007.
