14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 15 MARYLAND, That the Laws of Maryland read as follows:

- 16 Article Health General
- 17 10–308.

(a) Except as otherwise provided in subsections (c) and (d) of this section, the
 governing body of each county shall establish a mental health advisory committee.

1 (b) The purpose of a mental health advisory committee shall be to serve as 2 advocate for a comprehensive mental health system for persons of all ages.

- 3 (c) The governing bodies of two or more counties may establish, by 4 agreement, an intercounty mental health advisory committee if:
- 5 (1) The population of one of the counties is too small to warrant the 6 establishment of a mental health advisory committee for that county; and
