Public Safety Employees Killed in the Performance of Duties - Helicopter Pilots and Aviation Maintenance Technicians Public Safety Aviation Employees - Death Benefits

5 FOR the purpose of defining the term "rescue squad member" as it relates including 6 <u>certain public safety aviation employees within certain provisions relating</u> to 7 eligibility for certain death benefits and funeral expenses so as to include 8 certain helicopter pilots and aviation maintenance technicians; and generally 9 relating to death benefits for public safety employees killed in the performance 10 of duties.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 17 MARYLAND, That the Laws of Maryland read as follows:
