### Nonprofit Health Service Plans - Boards of Directors - Term Limits and Compensation

4 FOR the purpose of altering the number of terms and the total number of years that 5 may be served by a member of the board of directors of a nonprofit health 6 service plan; altering the amount and type of compensation that may be 7 received by a board member; requiring the Maryland Insurance Commissioner to make a certain review in a certain manner about the amount of compensation 8 9 to be paid to board members; requiring the Commissioner to submit a certain report to certain committees of the General Assembly on or before a certain date 10 each year; altering the requirement that a certain corporation report certain 11 information to the Commissioner; and generally relating to the boards of 12 13 directors of nonprofit health service plans.

# GOVERNMENT ARTICLE, THE RESULTS OF THE REVIEW UNDER SUBPARAGRAPH (II) OF THIS PARAGRAPH TO THE SENATE FINANCE COMMITTEE AND THE HOUSE HEALTH AND GOVERNMENT OPERATIONS COMMITTEE.

4 (2) A board member may not receive more than the amount specified 5 in paragraph (1) of this subsection for serving on more than one board of a corporation 6 subject to this section.

- (3) (i) This paragraph applies to a corporation that is:
- 8 1. issued a certificate of authority as a nonprofit health9 service plan; and
- 10 2. the sole member of a corporation issued a certificate of
  11 authority as a nonprofit health service plan.

(ii) [On or before March 1, 2004, and annually thereafter, a
 corporation subject to this paragraph shall report to the Commissioner on the amount
 of the ordinary and necessary expenses paid to each board member in the preceding
 calendar year.] ON OR BEFORE JUNE 30 OF EACH CALENDAR YEAR, A
 CORPORATION SUBJECT TO THIS PARAGRAPH SHALL REPORT TO THE
 COMMISSIONER ON:

THE TOTAL AMOUNT OF BASE COMPENSATION,
 COMPENSATION FOR ATTENDANCE AT MEETINGS, AND REIMBURSEMENT FOR
 ORDINARY AND NECESSARY EXPENSES PAID TO EACH BOARD MEMBER IN THE
 PRECEDING CALENDAR YEAR; AND

22 2. THE PROPOSED ANNUAL COMPENSATION,
 23 TOGETHER WITH NECESSARY SUPPORTING DOCUMENTATION, TO BE PAID TO
 24 BOARD MEMBERS FOR THE NEXT CALENDAR YEAR.
