1 AN ACT concerning

- FOR the purpose of designating the English language as the official language of the State of Maryland; making provisions of this Act severable; and generally relating to the formal recognition of English as the official language of the State of Maryland.

- WHEREAS, Maryland comprises people from many ethnic, cultural, and linguistic backgrounds, all of whom have contributed to this State the richness of their heritages; and
- WHEREAS, Maryland has been greatly enriched by this diversity, and the government should always take steps to promote the dignity of all the heritages that form this State's pluralistic society; and

1 2 3	WHEREAS, It is not the purpose of this Act nor may this Act be construed to infringe on the rights of citizens to exercise the use of a language of their choice for private conduct; now, therefore,

13	(B) THE PROVISIONS OF THIS SECTION APPLY TO:
14 15	(1) THE LEGISLATIVE, EXECUTIVE, AND JUDICIAL BRANCHES OF GOVERNMENT; AND
16 17 18	(2) THE STATE AND EACH POLITICAL SUBDIVISION AND MUNICIPAL CORPORATION OF THE STATE, INCLUDING EACH DEPARTMENT, AGENCY, UNIT, ORGANIZATION, AND INSTRUMENTALITY THEREOF.
19	(C) AN ENTITY SUBJECT TO THE PROVISIONS OF THIS SECTION SHALL:

AND BE IT FURTHER ENACTED, That if any provision of this Act or the application thereof to any person or circumstance is held invalid for any reason in a court of competent jurisdiction, the invalidity does not affect other provisions or any other application of this Act which can be given effect without the
