- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That the Laws of Maryland read as follows:

Article - Election Law 16

- 18 Each regular member of a local board shall receive the salary and reimbursement of expenses provided in the county budget, but in no event may the 19
- 20 annual compensation be less than the following amounts:

- 3 (b) (1) Consistent with paragraph (2) of this subsection, each substitute 4 member shall be compensated for each day of service as provided in the county budget.
- 5 (2) (i) Except as provided in subparagraph (ii) of this paragraph, a 6 substitute member shall be compensated at a rate of at least \$25 for each meeting of 7 the local board that the substitute member attends.
- 8 (ii) 1. In Baltimore City, a substitute member shall be paid \$200 for each meeting that the substitute member attends.
- 10 2. In Calvert County, a substitute member shall be paid at least \$50 for each meeting that the substitute member attends.

3. IN FREDERICK COUNTY, A SUBSTITUTE MEMBER SHALL BE PAID \$3,600 ANNUALLY.

- 19 [5.] **6**. In Washington County, a substitute member 20 shall be paid \$75 for each meeting that the substitute member attends.
- 21 [6.] **7.** In Wicomico County, a substitute member shall 22 be paid \$1,200 annually.
- SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 35 of the Maryland Constitution, this Act may not be construed to extend or apply to the salary or compensation of the president and other members of the Frederick County Board of Elections in office on the effective date of this Act, but the provisions of this Act concerning the salary or compensation of the president and other members of the Frederick County Board of Elections shall take effect at the beginning of the next following term of office.
- 30 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 31 October 1, 2007.
