15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 16 MARYLAND, That the Laws of Maryland read as follows:

3 **B.** THE BOARD OF COUNTY COMMISSIONERS MAY ENTER INTO A 4 PERSONAL SERVICE CONTRACT WITH AN INDIVIDUAL FOR A NONMERIT 5 POSITION.

6 C. A PERSONAL SERVICE CONTRACT ENTERED INTO IN ACCORDANCE 7 WITH THIS SECTION SHALL END NO LATER THAN 180 DAYS AFTER THE 8 BEGINNING OF THE TERM OF OFFICE OF THE NEXT SUCCEEDING BOARD OF 9 COUNTY COMMISSIONERS.

10 **D.** ANY PERSONAL SERVICE CONTRACT ENTERED INTO IN 11 ACCORDANCE WITH THIS SECTION SHALL CONTAIN A PROVISION THAT 12 AUTHORIZES THE BOARD OF COUNTY COMMISSIONERS TO ASSIGN THE 13 INDIVIDUAL TO ANY OTHER DUTIES THAT MAY BE APPROPRIATE AND 14 NECESSARY DURING THE TERM OF THE CONTRACT.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect16 October 1, 2007.
