A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Funding Accountability and Transparency Act of 2007**

3 FOR the purpose of requiring the Department of Budget and Management to develop
4 and operate a specified website that includes specified information for certain
5 State financial assistance and expenditures; specifying certain parameters of
6 the website; authorizing the Secretary of Budget and Management to designate
7 certain agencies to participate in the development, operation, or support of the
8 website; authorizing the Secretary to determine the best and most appropriate
9 data sources for the website; defining certain terms; providing that certain
10 provisions of law may not be construed to require the disclosure of certain
11 confidential information; and generally relating to a searchable website to be
12 developed and operated by the Department of Budget and Management to
13 provide information to the public on State financial assistance and
14 expenditures.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article – State Finance and Procurement**

4 **3–101.**

- 5 (a) In this title the following words have the meanings indicated.
6 (b) “Department” means the Department of Budget and Management.
7 (c) “Secretary” means the Secretary of Budget and Management.

8 **3–207.**

9 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE
10 MEANINGS INDICATED.

11 (2) (I) “ENTITY” MEANS, WHETHER FOR PROFIT OR
12 NONPROFIT, ANY:

13 1. CORPORATION, ASSOCIATION, PARTNERSHIP,
14 LIMITED LIABILITY COMPANY, LIMITED LIABILITY PARTNERSHIP, SOLE
15 PROPRIETORSHIP, OR OTHER LEGAL BUSINESS ENTITY;

16 2. OTHER GRANTEE, CONTRACTOR,
17 SUBCONTRACTOR, OR SUBGRANTEE; OR

18 3. POLITICAL SUBDIVISION.

19 (II) “ENTITY” DOES NOT INCLUDE AN INDIVIDUAL WHO IS
20 THE RECIPIENT OF STATE OR FEDERAL ASSISTANCE PAYMENTS OR A STATE
21 EMPLOYEE WHO IS THE RECIPIENT OF STATE SALARY OR WAGES.

22 (3) (I) “STATE AWARD” MEANS ANY STATE FINANCIAL
23 ASSISTANCE OR EXPENDITURES OVER THE AMOUNT OF \$25,000, INCLUDING:

1 **1. GRANTS, SUBGRANTS, LOANS, AWARDS,**
2 **COOPERATIVE AGREEMENTS, AND OTHER FORMS OF FINANCIAL ASSISTANCE;**
3 **AND**

4 **2. CONTRACTS, SUBCONTRACTS, PURCHASE**
5 **ORDERS, AND OTHER PAYMENTS.**

6 **(II) "STATE AWARD" DOES NOT INCLUDE FUNDS**
7 **TRANSFERRED FROM ONE AGENCY TO ANOTHER.**

8 **(4) "SEARCHABLE WEBSITE" MEANS A WEBSITE THAT ALLOWS**
9 **THE PUBLIC TO:**

10 **(I) SEARCH AND AGGREGATE STATE FUNDING BY ANY**
11 **ELEMENT REQUIRED UNDER SUBSECTION (B) OF THIS SECTION;**

12 **(II) ASCERTAIN THROUGH A SINGLE SEARCH THE TOTAL**
13 **AMOUNT OF STATE FUNDING AWARDED TO AN ENTITY BY A STATE AWARD; AND**

14 **(III) DOWNLOAD DATA THAT RESULTS FROM A SEARCH.**

15 **(B) ON OR BEFORE JANUARY 1, 2008, THE DEPARTMENT SHALL**
16 **DEVELOP AND OPERATE A SINGLE, SEARCHABLE WEBSITE, ACCESSIBLE BY THE**
17 **PUBLIC AT NO COST, THAT INCLUDES FOR EACH STATE AWARD:**

18 **(1) THE NAME OF THE ENTITY RECEIVING THE AWARD AND, IF**
19 **APPLICABLE, THE PARENT ENTITY OF THE RECIPIENT;**

20 **(2) THE AMOUNT OF THE AWARD;**

21 **(3) THE TRANSACTION TYPE;**

22 **(4) THE NAME OF THE AGENCY MAKING THE AWARD;**

23 **(5) THE BUDGET PROGRAM FUND SOURCE;**

24 **(6) A DESCRIPTIVE PURPOSE OF EACH FUNDING ACTION OR**
25 **STATE AWARD;**

1 **(7) THE LOCATION OF THE ENTITY RECEIVING THE AWARD AND**
2 **THE PRIMARY LOCATION OF PERFORMANCE UNDER THE AWARD; AND**

3 **(8) ANY OTHER RELEVANT INFORMATION SPECIFIED BY THE**
4 **DEPARTMENT.**

5 **(C) THE SINGLE WEBSITE PROVIDED FOR IN SUBSECTION (B) OF THIS**
6 **SECTION SHALL ALLOW THE USER TO:**

7 **(1) SEARCH DATA FOR FISCAL YEAR 2008 AND EACH FISCAL YEAR**
8 **THEREAFTER;**

9 **(2) SEARCH ELECTRONICALLY BY FIELD IN A SINGLE SEARCH;**
10 **AND**

11 **(3) PROVIDE INPUT REGARDING THE UTILITY OF THE SITE AND**
12 **RECOMMENDATIONS FOR IMPROVEMENT.**

13 **(D) THE SECRETARY MAY:**

14 **(1) DESIGNATE ONE OR MORE STATE AGENCIES TO PARTICIPATE**
15 **IN THE DEVELOPMENT, OPERATION, OR SUPPORT OF THE SINGLE WEBSITE AND**
16 **SPECIFY THE SCOPE OF RESPONSIBILITIES OF THOSE AGENCIES; AND**

17 **(2) DETERMINE THE BEST AND MOST APPROPRIATE DATA**
18 **SOURCE OR SOURCES FOR DEVELOPMENT AND OPERATION OF THE SINGLE**
19 **WEBSITE.**

20 **(E) STATE AGENCIES SHALL COMPLY WITH THE PROVISIONS OF**
21 **SUBSECTION (D) OF THIS SECTION AND SHALL PROVIDE APPROPRIATE**
22 **ASSISTANCE TO THE SECRETARY TO ENSURE THE EXISTENCE AND OPERATION**
23 **OF THE SINGLE WEBSITE.**

24 **(F) THIS SECTION MAY NOT BE CONSTRUED TO REQUIRE THE**
25 **DISCLOSURE OF INFORMATION THAT IS CONSIDERED CONFIDENTIAL BY STATE**
26 **OR FEDERAL LAW.**

27 **(G) THIS SECTION SHALL BE KNOWN AND MAY BE CITED AS THE**
28 **“MARYLAND FUNDING ACCOUNTABILITY AND TRANSPARENCY ACT OF 2007”.**

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
2 October 1, 2007.
