House Bill 910 Judiciary

Judicial Proceedings

#### Public Safety - Correctional Officers - Minimum Age

This bill provides that the Secretary of Public Safety and Correctional Services must adopt regulations requiring that a correctional officer hired by the Division of Correction (DOC) on or after October 1, 2007 be at least 21 years old. The regulations must exempt any honorably discharged veteran or reserve member of the U.S. armed forces from the minimum age requirement.

#### **Fiscal Summary**

**State Effect:** Potential minimal effect on DOC operations and finances. No effect on revenues.

Local Effect: None.

Small Business Effect: None.

### Analysis

**Current Law:** Under current regulations, an applicant for a State or local correctional officer position must be at least 18 years old, be a U.S. citizen or resident alien (and submit proof of status), and possess at least a high school diploma or a General Education Development certificate. A college degree may be accepted in place of the high school diploma.

**State Fiscal Effect:** This bill should not have a significant fiscal or operational impact on DOC. DOC hiring data shows relatively few correctional officers under 21. Of the

current 4,881 correctional officers in DOC, 173 are under that age. The extent to which this bill could affect the agency's ability to fill future vacancies cannot be reliably predicted. Any prolonged vacancies could lead to additional overtime costs.

**Exhibit 1** sets forth the systemwide interviews and hiring done by the Department of Public Safety and Correctional Services (DPSCS) over the past four years. It shows that the number of new hires under 21 is steadily increasing.
