#### 10. Description and Purpose of Grantee Organization (3000 characters maximum)

THE NATIONAL PHILIPPINE CULTURAL FOUNDATION, INC.

The National Philippine Cultural Foundation, Inc. was formed to serve as the vehicle for raising additional funds needed in putting up the facilities, specifically, the National Philippine Multi-Cultural Center. The Foundation will also oversee the activities of the center.

The goals of the National Philippine Multi-Cultural Center are:

- 1. To instill in the Filipino-American community in the Prince George's County, the Metro-Washington area, and the U.S. pride in their Philippine heritage as a valuable contribution to the total American way of life.
- 2. To develop awareness among the general population of the beauty of the Philippine Cultural heritage and the value of the contributions of the Filipino-American community to the economic, social, cultural, and religious life of the county, the state, and the entire country.
- 3. To provide the physical facilities as a venue for the above-mentioned activities of the Center and of other groups who may be interested to utilize the same in promoting the objectives of the Center.
- 4. To serve as the link between the Filipino community and the other ethnic groups as well as the rest of the community.
- 5. To provide a showcase of Philippine and other ethnic culture through exhibits, expositions relating to arts and culture (music, dance, architecture, artifacts, handicrafts, festival, and food).
- 6. To serve as venue for movies and stage presentations, economic missions, business conferences/meetings, and other related functions/events.
- 7. To work for closer cooperation and relationship with the whole community.

## 11. Description and Purpose of Project (3000 characters maximum)

THE PROJECT – THE NATIONAL PHILIPPINE MULTI-CULTURAL CENTER FACILITIES:

The center shall consist of a building of a least 40,000 sq. feet on at least 4 acres of land with ample parking space and provisions for possible expansions and other related structures. The building shall house the general offices and a spacious auditorium/exhibition hall.
