#### Howard County - Zoning Regulations - Administrative Proceedings Ho. Co. 5-07

This bill authorizes the Howard County Council to adopt an ordinance to enforce zoning regulations through administrative proceedings. The ordinance may include the authority to impose civil fines and penalties and to create liens and assess costs for zoning violations.

#### **Fiscal Summary**

State Effect: None.

**Local Effect:** Howard County expenditures could increase by \$247,000 in FY 2008 assuming an ordinance is adopted by the county council authorizing zoning violations to be enforced through administrative proceedings. Future year expenditures would increase by 5% to 8% annually depending on salary enhancements and the number of proceedings. Revenues would not be affected.

Small Business Effect: None.

#### Analysis

**Current Law:** Civil penalties may be assessed for zoning violations if provided for by a local legislative body. A fine of up to \$500 may be imposed for each violation, though a local legislative body may also establish additional fines for each violation and adopt procedures to collect the fines.

A person who receives a citation for a zoning violation may elect to stand trial in District Court. If a person does not respond to a citation, the person can be subject to an additional fine and the zoning official may request that the District Court adjudicate the violation. Upon request of a zoning official, the District Court must schedule the case for trial and summon the defendant to appear. A violation is prosecuted in the same manner as a municipal infraction and the governing body of a county may authorize the county attorney to prosecute a violation.

**Local Fiscal Effect:** Howard County currently pursues zoning violations in court. An administrative proceeding process would presumably allow zoning regulations to be enforced in a more efficient manner. Howard County advises that expenditures could increase by \$247,000 in fiscal 2008 to set up an administrative proceedings office, assuming an ordinance is passed by the county council allowing for zoning violations to be enforced through administrative proceedings. This estimate reflects the cost of hiring a senior attorney hearing officer and a clerical assistant, one-time start-up costs, and ongoing operating expenses.
