Retrofitting of existing heavily used athletic fields at three regional recreation sites, replacing grass fields with artificial turf fields. The three sites involved are Northwest Regional Park, Meadowood Regional Park, and Community College of Baltimore County – Essex (CCBC-Essex). The fields at these sites serve a large number of communities and recreation councils, with CCBC-Essex's facilities also used for scholastic sports. The installation of artificial turf will insure that the fields remain available for use, and will help to rectify ongoing problems with field wear associated with heavy facility use. These projects may also involve associated minor capital equipping and landscaping.
