10. Description and Purpose of Grantee Organization (3000 characters maximum)				
Zion Christian Middle School's mission is to provide an excellent education for adolescents in grades 6, 7, and 8 that includes instruction in English, Mathematics, Science, Social Studies, Art, Music, Character Education, Spanish, and Physical Education. The school strives to equip students with the skills necessary to achieve success in high school and beyond. Due to lack of space, however, there is no gymnasium, auditorium, computer lab or science lab.

A multipurpose 16,000 square feet building would be constructed on school grounds at 4915 Holder Avenue to provide the space needed to house a gymnasium, locker rooms, auditorium, computer lab, science lab, and meeting rooms. Such a building would allow the school to more fully address the academic, physical and social needs of the students it serves. Major construction materials would include concrete block with brick veneer. Students would utilize the facility during the school day and community residents could use it after school hours. Employment opportunities would be available for several individuals.
