The St. Clements Hundred is preparing to rebuild the Blackistone Lighthouse on St. Clements Island. The lighthouse was built in 1851 and operated until 1932. This important historical focus of St. Mary's County and the State of Maryland became unsafe and was destroyed in 1956. The rebuilt lighthouse will serve as a historical educational marker and an attraction for visitors.
