1 AN ACT concerning

Jessica's Law - Sexual Offenses - Parole Eligibility and Mandatory Minimum Sentences

4 FOR the purpose of providing that persons who are convicted of certain sexual offenses 5 are not eligible for parole during certain mandatory minimum sentences; 6 prohibiting a certain person from engaging in certain sexual contact with a child 7 who is under a certain age; establishing a certain penalty; prohibiting a court 8 from suspending any part of a sentence for a certain sexual offense committed 9 against a child under a certain age; requiring the State to provide a certain notification if the State intends to seek a certain sentence under certain 10 11 circumstances; creating a certain exception; and generally relating to sexual offenses involving children. 12

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF19 MARYLAND, That the Laws of Maryland read as follows:
