## A BILL ENTITLED

### 1 AN ACT concerning

13	(a) There is a Commission to Study Maryland's Tax Structure.		
14	(b) The Commission shall be composed of 15 members, as follows:		
15	(1) a Chair, appointed by the Governor;
