AMENDMENT TO SENATE BILL 90  
(Third Reading File Bill – Committee Reprint)

On page 245, after line 11, insert:

“SECTION 42. AND BE IT FURTHER ENACTED, That, notwithstanding Section 12 of this Act, certain salaries of positions in the Executive Pay Plan shall be limited to the amounts listed below. In implementing this Section, the Governor shall effect reductions of not less than the following amounts by fund type:

<u>General Funds</u>	<u>\$554,318</u>
<u>Special Funds</u>	<u>\$ 95,800</u>
<u>Federal Funds</u>	<u>\$ 31,223</u>

It is the intent of the General Assembly to limit increases in each position in the Executive Pay Plan listed below, which equates to a 2% increase over the amounts shown in the fiscal year 2008 budget bill.
