AMENDMENTS TO SENATE BILL 201 (Third Reading File Bill)

AMENDMENT NO. 1

On page 1, at the top of the page, strike "CONSTITUTIONAL AMENDMENT"; strike line 2 in its entirety and substitute "<u>Elections – Voter Registration and Voting – Age</u>"; and strike beginning with "authorizing" in line 3 down through "rejection." in line 6 and substitute "<u>altering the qualifications for voter registration to allow an individual who is at least 16 years old to register to vote; specifying that an individual under the age of 18 years may vote in certain primary elections but may not vote in any other elections; and generally relating to the age when an individual becomes qualified to register to vote.</u>

BY repealing and reenacting, with amendments,

<u>Article – Election Law</u> <u>Section 3-102</u> <u>Annotated Code of Maryland</u> (2003 Volume and 2007 Supplement)

<u>SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF</u> <u>MARYLAND, That the Laws of Maryland read as follows:</u>".

On pages 1 and 2, strike in their entirety the lines beginning with line 7 on page 1 through line 20 on page 2, inclusive.

On page 2, after line 20, insert:

"<u>Article – Election Law</u>

<u>3-102.</u>

(a) (1) Except as provided in subsection (b) of this section, an individual may become registered to vote if the individual:

[(1)] (I) is a citizen of the United States;

[(2)] (II) is at least [18] **16** years old [or will be 18 years old on or before the day of the next succeeding general or special election];

[(3)] (III) is a resident of the State as of the day the individual seeks to register; and

[(4)] (IV) registers pursuant to this title.

(2) NOTWITHSTANDING PARAGRAPH (1)(II) OF THIS SUBSECTION, AN INDIVIDUAL UNDER THE AGE OF 18 YEARS:

(I) MAY VOTE IN A PRIMARY ELECTION IN WHICH CANDIDATES ARE NOMINATED FOR A GENERAL OR SPECIAL ELECTION THAT WILL OCCUR WHEN THE INDIVIDUAL IS AT LEAST 18 YEARS OLD; AND

(II) MAY NOT VOTE IN ANY OTHER ELECTION.

(b) An individual is not qualified to be a registered voter if the individual:

(1) <u>has been convicted of a felony and is actually serving a court-</u> <u>ordered sentence of imprisonment, including any term of parole or probation, for the</u> <u>conviction;</u> SB0201/255763/1 Amendments to SB 201 Page 3 of 3

- (2) is under guardianship for mental disability; or
- (3) has been convicted of buying or selling votes.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2008.".
