On page 2, in line 9, strike "land bank authorities" and substitute "<u>the</u> <u>Baltimore City Land Bank Authority</u>"; in line 12, before "Land" insert "<u>Baltimore City</u>"; and in line 13, strike "Authorities" and substitute "<u>Authority</u>".

"(B) EXCEPT AS OTHERWISE PROVIDED IN THIS TITLE OR THE ORDINANCE ESTABLISHING AN AUTHORITY, THE PROCEDURES OF BALTIMORE CITY CONTROL ANY MATTER RELATING TO THE INTERNAL ADMINISTRATION OF THE AUTHORITY.";

and in line 30, strike "HAS" and substitute "MAY HAVE".

On page 11, strike beginning with "**AN**" in line 2 down through "(**B**)" in line 7; in line 15, strike the second "**AND**"; in line 16, strike "**REMEDIATE ENVIRONMENTAL CONTAMINATION**" and substitute "<u>**ABATE VIOLATIONS OF THE LOCAL AND STATE**</u> **BUILDING, FIRE, HEALTH, AND RELATED CODES; AND**

On page 14, strike beginning with "WITH" in line 10 down through "FILED" in line 11 and substitute "IN ACCORDANCE WITH THE MARYLAND RULES"; in line 18, after "LOCAL" insert "<u>:</u>

in the same line, strike "ZONING" and substitute "ZONING LAWS;

(2) <u>PERMITTING PROCESSES FOR CONSTRUCTION, DEMOLITION,</u> OR REPAIR OF A PROPERTY;";

in the same line, strike "LAND" and substitute:

"<u>(3)</u> <u>LAND</u>";
