(2) <u>A LEASE OF LAND, A BUILDING, OR A FACILITY OR A</u> <u>CONTRACT FOR AN EVENT OR CONCESSION THAT IS EXECUTED BY THE</u> <u>EXECUTIVE DIRECTOR:</u>

(I) MAY NOT BE FOR A TERM OF MORE THAN 5 YEARS OR BE RENEWED FOR MORE THAN AN ADDITIONAL 5 YEARS; AND

(II) SHALL BE REVIEWED AND APPROVED BY THE COMMISSION AND OFFICE OF THE ATTORNEY GENERAL.

(3) <u>A LEASE ENTERED INTO BEFORE THE CREATION OF THE</u> <u>COMMISSION SHALL REMAIN IN EFFECT FOR THE DURATION OF THE TERM OF</u> <u>THE LEASE.</u>

(4) (1) <u>THE EXECUTIVE DIRECTOR MAY NOT EXECUTE A LEASE</u> OR CONTRACT FOR NONBOATING RELATED IMPROVEMENTS OR GOODS AT THE MARINA WITHOUT THE APPROVAL OF THE SECRETARY.

(II) WITHIN 30 DAYS AFTER RECEIVING A REQUEST FOR APPROVAL OF A LEASE OR CONTRACT, THE SECRETARY SHALL PROVIDE THE EXECUTIVE DIRECTOR WITH AN INITIAL RESPONSE THAT MAY INCLUDE A PROCESS OR PLAN OF ACTION FOR ADDRESSING THE MERITS OF THE REQUEST.

(E) (1) THE EXECUTIVE DIRECTOR SHALL PROCURE GOODS AND SERVICES IN ACCORDANCE WITH THE REQUIREMENTS OF THIS SUBSECTION.

(2) FOR GOODS AND SERVICES WITH AN EXPECTED VALUE OF \$1,000 TO \$5,000, THE EXECUTIVE DIRECTOR SHALL:

- (I) MAKE A WRITTEN OR TELEPHONE REQUEST FOR BIDS;
- (II) **EVALUATE THE BIDS; AND**

(III) <u>AWARD THE CONTRACT TO THE RESPONSIBLE BIDDER</u> <u>THAT SUBMITS THE RESPONSIVE BID THAT IS THE LOWEST BID PRICE.</u>

(3) FOR GOODS AND SERVICES WITH AN EXPECTED VALUE OF MORE THAN \$5,000, THE EXECUTIVE DIRECTOR SHALL:

(I) <u>ADVERTISE THE SOLICITATION IN A LOCAL NEWSPAPER</u> <u>AND ON THE SOMERSET COUNTY WEBSITE;</u>

(II) ISSUE INVITATIONS FOR BIDS TO ALL KNOWN PROSPECTIVE VENDORS; HB1463/700014/1 Amendments to HB 1463 Page 5 of 6 ENV

(III) TABULATE AND EVALUATE THE BIDS;

(IV) <u>SELECT FOR AWARD THE RESPONSIBLE BIDDER WHO</u> SUBMITS THE RESPONSIVE BID THAT IS THE LOWEST BID PRICE; AND

(V) <u>SUBMIT THE PROPOSED AWARD TO THE COMMISSION</u> FOR REVIEW AND APPROVAL.

(4) <u>THE EXECUTIVE DIRECTOR SHALL ADOPT A PROCUREMENT</u> <u>POLICY THAT INCLUDES PROVISIONS FOR MINORITY BUSINESS</u> <u>PARTICIPATION.</u>".
