AMENDMENTS TO HOUSE BILL 934
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 8, after “projects;” insert “requiring the Commission to communicate its reasons to certain persons if the Commission does not approve a certain proposed facility without conditions under certain circumstances;”; in line 16, strike “and” and substitute “in consultation with”; in line 17, strike “strive to”; in line 18, strike “utilize” and substitute “enhance”; in line 20, strike “conjunction” and substitute “consultation”; in line 22, strike “each public employment facility” and substitute “certain persons that regularly employ more than a certain number of employees located”; and in line 23, strike “provide” and substitute “report to the Commission regarding”.

AMENDMENT NO. 2

On page 3, in line 1, after “**PROPOSED**” insert “PUBLIC”; in line 4, strike “**UTILIZE**” and substitute “ENHANCE”; in line 7 after “**APPROVE**” insert “WITHOUT CONDITION”; and in line 25, after “submitting” insert “PUBLIC”.

AMENDMENT NO. 3

On page 6, strike beginning with “**TO**” in line 2 down through “**TRAFFIC**” in line 3; in line 6, strike the first comma and substitute “AND”; strike beginning with the second comma in line 6 down through “**DISTRICT**” in line 8; in line 9, after “**AREA**” insert “IN CONSULTATION WITH THE MARYLAND-NATIONAL CAPITAL PARK AND PLANNING COMMISSION”; in line 11, after the first “**AND**” insert “IN CONSULTATION WITH”; in line 12, strike “**IN THE MARYLAND-WASHINGTON REGIONAL DISTRICT**”; in line 15, after “**PLAN**” insert “TO INCREASE SAFETY AND ACCESS FOR BICYCLE OR PEDESTRIAN TRAFFIC”; in line 16, strike “**AND**” and substitute “IN CONSULTATION WITH”; strike beginning with “**IN**” in line 17 down

through “**DISTRICT**” in line 18; and in line 34, strike “**UTILIZE**” and substitute “**ENHANCE**”.

AMENDMENT NO. 4

On page 7, in line 2, strike “**WHEN APPLICABLE,**” and substitute “**IN THE MARYLAND-WASHINGTON REGIONAL DISTRICT, IN CONSULTATION WITH**”; strike beginning with “**IN**” in line 3 down through “**DISTRICT**” in line 4; in line 22, strike “**A**” and substitute “**THE**”; in line 23, strike “**UTILIZE**” and substitute “**ENHANCE**”; and in line 26, after “**AND**” insert “**IN CONSULTATION WITH**”.

On pages 7 and 8, strike beginning with “**2010**” in line 33 on page 7 down through “**BICYCLES**” in line 2 on page 8 and substitute “**2010, EACH STATE, FEDERAL, COUNTY, MUNICIPAL, OR PUBLIC DISTRICT, BOARD, BODY, OR OFFICIAL THAT REGULARLY EMPLOYS MORE THAN 50 EMPLOYEES LOCATED IN THE MARYLAND-WASHINGTON REGIONAL DISTRICT SHALL REPORT TO THE MARYLAND-NATIONAL CAPITAL PARK AND PLANNING COMMISSION A PLAN FOR PROVIDING REASONABLE ACCOMMODATIONS FOR BICYCLE ACCESS, INCLUDING PARKING FACILITIES FOR BICYCLES UTILIZED BY VISITORS AND EMPLOYEES AT APPROPRIATE PUBLIC FACILITIES AND LOCATIONS**”.
