On page 25, in line 27, strike "HAS" and substitute ":

(2) HAS".

AMENDMENT NO. 3

On page 26, after line 20, insert:

"SECTION 3. AND BE IT FURTHER ENACTED, That, on or before December 31, 2010, the Department of Housing and Community Development shall report to the General Assembly, in accordance with § 2-1246 of the State Government Article, on:

- (1) the number and location of government agencies and nonprofit organizations approved in accordance with this Act;
- (2) the number and type of home buyer education or housing advice sessions conducted in accordance with this Act; and
- (3) any other information that the Department determines is relevant to determine the effectiveness of this Act.";

in line 21, strike "3." and substitute "4."; and in line 22, after "2008." insert "It shall remain effective for a period of 2 years and 8 months and, at the end of May 31, 2011, with no further action required by the General Assembly, this Act shall be abrogated and of no further force and effect.".
