AMENDMENT NO. 2

On page 2, after line 19, insert:

"(B) (1) FOR FISCAL YEAR 2009 AND EACH FISCAL YEAR THEREAFTER, THE ADMINISTRATION'S GOAL SHALL BE TO RECOVER FROM FARES AND OTHER OPERATING REVENUES AT LEAST 35 PERCENT OF THE TOTAL OPERATING COSTS FOR:

(I) <u>THE ADMINISTRATION'S BUS, LIGHT RAIL, AND METRO</u> <u>SUBWAY SERVICES IN THE BALTIMORE REGION; AND</u>

(II) <u>ALL PASSENGER RAILROAD SERVICES UNDER THE</u> <u>ADMINISTRATION'S CONTROL.</u>

(2) <u>THE ADMINISTRATION SHALL SUBMIT, IN ACCORDANCE WITH</u> <u>§ 2-1246 OF THE STATE GOVERNMENT ARTICLE, AN ANNUAL REPORT TO THE</u> <u>SENATE BUDGET AND TAXATION COMMITTEE, HOUSE WAYS AND MEANS</u>

(III) <u>COMPARISONS OF FAREBOX RECOVERY RATIOS FOR</u> <u>THE ADMINISTRATION'S MASS TRANSIT SERVICES AND OTHER SIMILAR TRANSIT</u> <u>SYSTEMS NATIONWIDE.</u>";

On page 2, in line 20, strike "(B)" and substitute "(C)".

On page 3, in lines 10, 20, 24, and 28, strike "(**C**)", "(**D**)", "(**E**)", and "(**F**)", respectively, and substitute "(**D**)", "(**E**)", "(**F**)", and "(**G**)", respectively.
