AMENDMENTS TO SENATE BILL 755, AS AMENDED  
(Third Reading File Bill)

AMENDMENT NO. 1

Strike the Committee on Ways and Means Amendments (SB0755/745961/1) in their entirety.

On page 1 of the bill, strike beginning with “requiring” in line 9 down through “time;” in line 11 and substitute “altering certain definitions; defining certain terms;”.

AMENDMENT NO. 2

On page 2 of the bill, strike lines 10 through 13, inclusive, and substitute:

**“(3) “CAMPAIGN FINANCE REPORT” MEANS A REPORT, STATEMENT, AFFIDAVIT, OR OTHER DOCUMENT THAT IS:**

**(I) AUTHORIZED OR REQUIRED UNDER THE ELECTION LAW ARTICLE OR THIS ACT;**

**(II) RELATED TO THE CAMPAIGN FINANCE ACTIVITIES OF A CAMPAIGN FINANCE ENTITY OR A PERSON; AND**

**(III) FILED OR SUBMITTED ON A FORM PRESCRIBED BY THE STATE BOARD UNDER THE ELECTION LAW ARTICLE OR THIS ACT.**

**(4) “CAMPAIGN MATERIAL” HAS THE MEANING STATED IN § 1-101(K) OF THE ELECTION LAW ARTICLE.**

(Over)

**(5) “EXPENDITURE” MEANS A GIFT, TRANSFER, DISBURSEMENT, OR PROMISE OF MONEY OR A THING OF VALUE BY OR ON BEHALF OF A CAMPAIGN FINANCE ENTITY OR PERSON TO PROMOTE THE SUCCESS OR DEFEAT OF THE CONSTITUTIONAL AMENDMENT PROPOSED BY CHAPTER 5 (H.B. 4) OF THE ACTS OF THE GENERAL ASSEMBLY OF THE SPECIAL SESSION OF 2007.”;**

in line 18, strike the colon; in line 19, strike “**(1)**”; and strike beginning with “**;** **AND**” in line 20 down through “**ELECTION**” in line 22.

**AMENDMENT NO. 3**

On page 2 of the bill, in line 23, after “**MAKES**” insert “**CUMULATIVE**”.

On page 3 of the bill, in line 2, strike “**PERSON**” and substitute “**INDIVIDUAL**”; in the same line, strike “**THE NAME OF THE INDIVIDUAL**”; and in line 15, after “**(3)**” insert “**EXCEPT FOR AN INDIVIDUAL WHO USES PERSONAL FUNDS AND ACTS INDEPENDENTLY OF OTHERS IN MAKING EXPENDITURES SUBJECT TO THIS SUBSECTION,**”.
