AMENDMENTS TO SENATE BILL 755, AS AMENDED (Third Reading File Bill)

AMENDMENT NO. 1

Strike the Committee on Ways and Means Amendments (SB0755/745961/1) in their entirety.

On page 1 of the bill, strike beginning with "requiring" in line 9 down through "time;" in line 11 and substitute "altering certain definitions; defining certain terms;".

AMENDMENT NO. 2

On page 2 of the bill, strike lines 10 through 13, inclusive, and substitute:

- "(3) "CAMPAIGN FINANCE REPORT" MEANS A REPORT, STATEMENT, AFFIDAVIT, OR OTHER DOCUMENT THAT IS:
- (I) AUTHORIZED OR REQUIRED UNDER THE ELECTION LAW ARTICLE OR THIS ACT;
- (II) RELATED TO THE CAMPAIGN FINANCE ACTIVITIES OF A
 CAMPAIGN FINANCE ENTITY OR A PERSON; AND
- (III) FILED OR SUBMITTED ON A FORM PRESCRIBED BY THE STATE BOARD UNDER THE ELECTION LAW ARTICLE OR THIS ACT.
- (4) "CAMPAIGN MATERIAL" HAS THE MEANING STATED IN § 1-101(K) OF THE ELECTION LAW ARTICLE.

(5) "EXPENDITURE" MEANS A GIFT, TRANSFER, DISBURSEMENT, OR PROMISE OF MONEY OR A THING OF VALUE BY OR ON BEHALF OF A CAMPAIGN FINANCE ENTITY OR PERSON TO PROMOTE THE SUCCESS OR DEFEAT OF THE CONSTITUTIONAL AMENDMENT PROPOSED BY CHAPTER 5 (H.B. 4) OF THE ACTS OF THE GENERAL ASSEMBLY OF THE SPECIAL SESSION OF 2007.";

in line 18, strike the colon; in line 19, strike "(1)"; and strike beginning with "<u>**; AND**</u>" in line 20 down through "<u>**ELECTION**</u>" in line 22.

AMENDMENT NO. 3

On page 2 of the bill, in line 23, after "MAKES" insert "CUMULATIVE".

On page 3 of the bill, in line 2, strike "<u>PERSON</u>" and substitute "<u>INDIVIDUAL</u>"; in the same line, strike "<u>THE NAME OF THE INDIVIDUAL</u>"; and in line 15, after "(3)" insert "<u>EXCEPT FOR AN INDIVIDUAL WHO USES PERSONAL FUNDS AND ACTS INDEPENDENTLY OF OTHERS IN MAKING EXPENDITURES SUBJECT TO THIS SUBSECTION,".</u>
