AMENDMENTS TO SENATE BILL 755
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 4, strike "certain persons" and substitute "a business entity"; in line 6, strike "certain persons" and substitute "the business entity"; strike beginning with "requiring" in line 9 down through "time;" in line 11; in lines 12 and 13, strike "certain persons" and substitute "a business entity"; and strike lines 14 through 18, inclusive.

AMENDMENT NO. 2

On page 2, strike lines 1 through 4, inclusive; strike lines 10 through 13, inclusive, and substitute:

"(3) "BUSINESS ENTITY" INCLUDES A CORPORATION, PARTNERSHIP, BUSINESS TRUST, OR LIMITED LIABILITY COMPANY.

(4) "CAMPAIGN FINANCE REPORT" MEANS A REPORT, STATEMENT, AFFIDAVIT, OR OTHER DOCUMENT THAT IS:

(I) AUTHORIZED OR REQUIRED UNDER THE ELECTION LAW ARTICLE OR THIS ACT;

(II) RELATED TO THE CAMPAIGN FINANCE ACTIVITIES OF A CAMPAIGN FINANCE ENTITY OR A BUSINESS ENTITY;

(III) FILED OR SUBMITTED ON A FORM PRESCRIBED BY THE STATE BOARD UNDER THE ELECTION LAW ARTICLE OR THIS ACT.

(Over)

(5) “CAMPAIGN MATERIAL” HAS THE MEANING STATED IN § 1-101(K) OF THE ELECTION LAW ARTICLE.

(6) “EXPENDITURE” MEANS A GIFT, TRANSFER, DISBURSEMENT, OR PROMISE OF MONEY OR A THING OF VALUE BY OR ON BEHALF OF A CAMPAIGN FINANCE ENTITY OR BUSINESS ENTITY TO PROMOTE THE SUCCESS OR DEFEAT OF THE CONSTITUTIONAL AMENDMENT PROPOSED BY CHAPTER 5 (S.B. 4/H.B. 4) OF THE ACTS OF THE GENERAL ASSEMBLY OF THE SPECIAL SESSION OF 2007.”;

in line 18, strike the colon; in line 19, strike “**(1)**”; and strike beginning with “**;** **AND**” in line 20 down through “**ELECTION**” in line 22.

AMENDMENT NO. 3

On page 2, in lines 23 and 30, in each instance, strike “**PERSON**” and substitute “**BUSINESS ENTITY**”; and in line 24, before “**EXPENDITURES**” insert “**CUMULATIVE**”.

On page 3, in line 2, strike “**PERSON**” and substitute “**INDIVIDUAL**”; in the same line, strike “**THE NAME OF THE INDIVIDUAL**”; and in lines 7, 8, and 17, in each instance, strike “**PERSON**” and substitute “**BUSINESS ENTITY**”.
