AMENDMENTS TO SENATE BILL 46

(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with the second "altering" in line 4 down through "years;" in line 6; strike beginning with "making" in line 10 down through "extent;" in line 11; and strike beginning with "providing" in line 14 down through "Act;" in line 15 and substitute "stating the intent of the General Assembly that certain appropriations be reduced and certain positions be abolished and requiring the Governor and the Chief Judge of the Court of Appeals to submit to the Board of Public Works by a certain date a schedule to implement certain reductions; requiring the Governor to transfer to the General Fund certain amounts in the Maryland Automobile Insurance Fund;".

On page 2, in line 3, strike " $\frac{10-102.1(d)(1)(i)}{10-105(a)}$, $\frac{11-101(m)}{10-105(a)}$ " and substitute " $\frac{11-101(m)}{10-105(a)}$ ".

AMENDMENT NO. 2

On pages 3 and 4, strike in their entirety the lines beginning with line 1 on page 3 through line 25 on page 4, inclusive.

AMENDMENT NO. 3

On page 7, strike in their entirety lines 22 through 26, inclusive; in line 27, strike "<u>5.</u>" and substitute "<u>2.</u>"; and strike in their entirety lines 32 and 33 and substitute:

"SECTION 3. AND BE IT FURTHER ENACTED, That it is the intent of the General Assembly that, in addition to the reductions in expenditures provided for under Section 2 of this Act, notwithstanding any other provision of law:

- (1) \$37,600,000 in general fund appropriations shall be reduced and 752 full-time equivalent regular positions in Executive Branch agencies shall be abolished. The Governor shall submit to the Board of Public Works not later than July 1, 2008, a schedule to implement this reduction; and
- (2) \$7,400,000 in general fund appropriations shall be reduced and 148 full-time equivalent regular positions in the Judicial Branch shall be abolished. The Chief Judge of the Court of Appeals shall submit to the Board of Public Works not later than July 1, 2008, a schedule to implement this reduction.

SECTION 4. AND BE IT FURTHER ENACTED, That, notwithstanding any other provision of law, on or before June 30, 2009, the Governor shall transfer to the General Fund \$57,000,000 of the funds in the Insured Division of the Maryland Automobile Insurance Fund established under § 20-201 of the Insurance Article."

On page 8, in line 1, strike "7." and substitute "5.".
