On page 6, in line 2, strike "CERTIFIED"; in line 3, strike "BANKING" and substitute "MANAGEMENT SERVICES"; and strike beginning with "ACTIONS" in line 4 down through "SUBCONTRACTORS" in line 10, inclusive, and substitute:
