AMENDMENTS TO SENATE BILL 657

(Third Reading File Bill)

AMENDMENT NO. 1

On page 2, in line 1, strike “certain disclosures and”; strike beginning with “requiring” in line 6 down through “circumstances;” in line 8; and strike beginning with “requiring” in line 9 down through “circumstances;” in line 11.

AMENDMENT NO. 2

On pages 2 and 3, strike in their entirety the lines beginning with line 32 on page 2 down through line 7 on page 3, inclusive.

AMENDMENT NO. 3

On page 1, in line 19, strike “postsecondary” and substitute “higher”.

On page 2 in line 13, and on page 10 in line 11, in each instance, strike “postsecondary” and substitute “higher”.

On page 3 in line 24, and on page 5 in line 33, in each instance, strike “POSTSECONDARY” and substitute “HIGHER”.

AMENDMENT NO. 4

On page 6, strike in their entirety lines 17 through 19, inclusive; and in line 20, strike “(4)” and substitute “(3)”.

On page 7, in line 1, strike “(5)” and substitute “(4)”.

AMENDMENT NO. 5

On page 7, strike beginning with “A” in line 5 down through “EDUCATION” in line 6, and substitute “AN INSTITUTION OF HIGHER EDUCATION”.

AMENDMENT NO. 6

On page 8, strike beginning with “**ON**” in line 5 down through “**MEMBER**” in line 8, and substitute “**NOT MORE THAN 3 WEEKS AFTER A FACULTY MEMBER OF AN INSTITUTION OF HIGHER EDUCATION**”; in line 10, strike “**INSTITUTION.**” and substitute “**INSTITUTION, THE INSTITUTION SHALL MAKE THE FOLLOWING INFORMATION AVAILABLE TO STUDENTS AND THE REST OF THE PUBLIC BY POSTING THE INFORMATION ON ITS WEBSITE:**”; strike in their entirety lines 11 and 12; and strike in their entirety lines 21 through 29, inclusive.

AMENDMENT NO. 7

On page 9, in line 1, strike “**(II)**” and substitute “**(2)**”; in line 2, strike “**SUBPARAGRAPH (I) OF THIS PARAGRAPH**” and substitute “**PARAGRAPH (1) OF THIS SUBSECTION**”; in line 4, strike “**1.**” and substitute “**(I)**”; in line 6, strike “**2.**” and substitute “**(II)**”; strike in their entirety lines 18 through 27, inclusive; and in line 28, strike “**(H)**” and substitute “**(G)**”.
