On pages 3 and 4, strike beginning with "40" in line 31 on page 3 down through "2010" in line 3 on page 4 and substitute " $\mathbf{1 3}$ LICENSES.

## (4) The Board of License Commissioners may not issue

 ADDITIONAL LICENSES WITHIN THE WATERFRONT ENTERTAINMENT RETAIL COMPLEX WITHOUT THE EXPRESS APPROVAL OF THE GENERAL ASSEMBLY".On page 4, strike line 30 in its entirety; and in line 31, after "AREA;" insert "AND".

On page 5, strike beginning with the semicolon in line 2 down through "AREA" in line 4; and strike lines 18 and 19 in their entirety.

On page 6 , after line 19 , insert:
"9-102.
(a-1) [A] EXCEPT AS PROVIDED IN SUBSECTION (A-2) OF THIS SECTION, A Class A, B, or D beer license, beer and wine license, or beer, wine and liquor license, except by way of renewal, may not be granted, transferred, or issued to, or for use in conjunction with, or upon the premises of any business establishment of the type commonly known as chain stores, supermarkets, or discount houses. This subsection does not apply to or affect any business establishment already holding such a license or the possibility of such licensee having the license transferred to a similar type of

business establishment. Discount houses do not include licensees who sell at discount prices.
(A-2) The Board of License Commissioners of Prince George's COUNTY MAY ISSUE OR APPROVE THE TRANSFER OF A CLASS A, B, OR D BEER AND WINE LICENSE OR A CLASS A, B, OR D BEER, WINE AND LIQUOR LICENSE TO A SUPERMARKET OR GROCERY STORE THAT IS WITHIN A WATERFRONT ENTERTAINMENT RETAIL COMPLEX, AS DEFINED BY COUNTY ORDINANCE.".

On page 7, strike in their entirety lines 3 through 7, inclusive.
