## **Fallen Soldier Privacy Act of 2008**

- FOR the purpose of prohibiting a person from using the name, portrait, picture, or
  image of a certain deceased soldier for certain purposes without prior consent
  from certain individuals; defining a certain term; establishing a certain penalty;

#### Preamble

WHEREAS, The State of Maryland recognizes the tremendous dedication and
sacrifice of those men and women who served in the armed forces and their
willingness to defend the freedoms that we as individuals hold dear; and

17 WHEREAS, This legislation was inspired by the untimely death of Eric 18 Kavanagh, a 20-year-old soldier and resident of Maryland, who was killed in action in 19 Iraq on September 20, 2006, during Operation Iraqi Freedom, and dedicated to every 20 man and woman in our armed forces who died protecting our country; and

21 WHEREAS, We believe that special honor should be given to those brave 22 soldiers and surviving family members; and
