AN ACT concerning 1

$\mathbf{2}$ Furnishing an Alcoholic Beverage to Underage Individual – Penalty

FOR the purpose of making it a misdemeanor for a person knowingly and willfully to 3 furnish an alcoholic beverage for consumption to an individual under the age of 4 21 years under certain circumstances; imposing a certain criminal penalty; $\mathbf{5}$ repealing certain provisions requiring the issuance of a civil citation to a person 6 7 who violates the prohibition against furnishing an alcoholic beverage for 8 consumption to an underage individual; clarifying the elements of a certain 9 alcoholic beverage violation; increasing the penalty for furnishing an alcoholic
