BY repealing and reenacting, with amendments, Chapter 57 of the Acts of the General Assembly of 2006 Section 3 and 4 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

[(h)] (I) The staff for the Commission shall be provided and coordinated by the Department of Legislative Services. The Department of Budget and Management, the Maryland Higher Education Commission, and the University System of Maryland shall also assign staff to assist the Commission.

1 SECTION 4. AND BE IT FURTHER ENACTED, That Section 3 of this Act shall 2 take effect July 1, 2006, and shall remain effective for a period of [1 year] 2 YEARS 3 and [10] 11 months and, at the end of [May 1, 2008] JUNE 1, 2009, with no further action required by the General Assembly, Section 3 of this Act shall be abrogated and 4 5 of no further force and effect. 6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency 7 measure, is necessary for the immediate preservation of the public healthy or safety, 8 has been passed by a yea and nay vote supported by three-fifths of all the members 9 elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted. 10
