- 4 (b) A person may not throw any object at or in the direction of any person riding a bicycle, **A PLAY VEHICLE**, an EPAMD, or a motor scooter.
- 6 (c) A person may not open the door of any motor vehicle with intent to strike, 7 injure, or interfere with any person riding a bicycle, **A PLAY VEHICLE**, an EPAMD, or 8 a motor scooter.
- 9 (D) THE DRIVER OF A MOTOR VEHICLE SHALL YIELD THE 10 RIGHT-OF-WAY TO A PERSON WHO IS RIDING A BICYCLE, A PLAY VEHICLE, AN 11 EPAMD, OR A MOTOR SCOOTER IN A DESIGNATED BICYCLE LANE.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2008.
