BE IT ENACTED BY THE GENERAL ASSEMBLY OF 13 MARYLAND, That the Laws of Maryland read as follows: 14 Article 24 - Political Subdivisions - Miscellaneous Provisions 15 15–102.1. 16 In this section, "distribute" means to: (a) 17 **(1)** Give, sell, deliver, dispense, or issue; 18 Offer to give, sell, deliver, dispense, or issue; or (2)

- 1 Cause or hire any person to give, sell, deliver, dispense, or issue or 2 offer to give, sell, deliver, dispense, or issue. 3 (b) This section applies only in **GARRETT COUNTY AND** St. Mary's County. 4 (c) A person may not: 5 Distribute any tobacco product to a minor, unless the minor is acting solely as the agent of the minor's employer who is engaged in the business of 6 distributing tobacco products; 7 8 (2)Distribute cigarette rolling papers to a minor; or 9 (3)Subject to subsection (d) of this section, distribute to a minor a coupon redeemable for a tobacco product. 10 11 Subsection (c)(3) of this section does not apply to the distribution of a coupon that is redeemable for a tobacco product if the coupon: 12 13 Is contained in a newspaper, magazine, or other type of publication and the coupon is incidental to the primary purpose of the publication; or 14 15 (2)Is sent through the mail. 16 (e) A person has not violated this section if: 17 The person examined the driver's license or other valid **(1)** government-issued identification presented by the recipient of a tobacco product, 18 19 cigarette rolling paper, or coupon redeemable for a tobacco product; and 20 (2)The license or other identification positively identified the recipient 21 as being at least 18 years old. 22 (f) [A] IN ST. MARY'S COUNTY, A person who violates this section is **(1)** committing a civil infraction and is subject to a civil penalty of: 2324 [(1)] (I) \$300 for the first violation; and 25[(2)] (II) \$500 for any subsequent violation within a 24-month period 26 from the previous citation.
- 27 (2) IN GARRETT COUNTY, A PERSON WHO VIOLATES THIS
 28 SECTION IS COMMITTING A CIVIL INFRACTION AND IS SUBJECT TO A CIVIL
 29 PENALTY NOT EXCEEDING \$300.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2008.
