11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 12 MARYLAND, That the Laws of Maryland read as follows:

  15 (a) There is a Joint Committee on Base Realignment and Closure.
- 16 (b) (1) The Committee consists of [12] **16** members.

## HOUSE BILL 152

1 (i) [six] **EIGHT** shall be members of the Senate of Maryland, 2 appointed by the President of the Senate; and

3 (ii) [six] EIGHT shall be members of the House of Delegates,
4 appointed by the Speaker of the House.

5 (c) From among the membership of the Committee, the President of the 6 Senate shall appoint a Senator to serve as the Senate Chair of the Committee, and the 7 Speaker of the House shall appoint a Delegate to serve as the House Chair of the 8 Committee.

9 (d) The Department of Legislative Services shall provide staff assistance to 10 the Committee.

11 (e) The Committee shall provide continuing legislative oversight of the 12 State's response to changes and opportunities occurring as a result of the Base 13 Realignment and Closure Process.

14 (f) The Committee shall oversee and participate, in cooperation with State 15 and local units, in the development of systems and processes that, with the intent of 16 accelerating planning and development so that the State is prepared to receive the 17 influx of jobs and personnel associated with the Base Realignment and Closure 18 process, fast track the approval of:

- 19 (1) transportation infrastructure;
- 20 (2) water and sewer infrastructure;
- 21 (3) State and local planning processes;
- 22 (4) affordable housing options;
- (5) education facilities, including public school and community college
   construction; and
- 25 (6) health care facilities and infrastructure.
- 26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 27 October 1, 2008.
