#### HOUSE BILL 300

1 (a) In this section, "noncollegiate educational institution" means a school or 2 other institution that offers an educational program but is not an institution of 3 postsecondary education, as defined in § 10–101 of this article.

5 (A) IN THIS SECTION, "NONCOLLEGIATE EDUCATIONAL INSTITUTION"
6 HAS THE MEANING STATED IN § 2–206(A) OF THIS SUBTITLE.

7 (B) EACH COUNTY BOARD AND EACH NONPUBLIC NONCOLLEGIATE 8 EDUCATIONAL INSTITUTION SHALL DEVELOP FOR ITS STUDENTS A MANDATORY 9 COURSE REGARDING CRIMINAL LAW AND CRIMINAL PROCEDURE TO BE 10 IMPLEMENTED DURING MIDDLE SCHOOL OR DURING THE EQUIVALENT 11 AGE-APPROPRIATE GRADE LEVEL.

12(c)THE STATE BOARD SHALL PROVIDE GUIDANCE AND ASSISTANCE, AS13NECESSARY, FOR THE IMPLEMENTATION OF THIS SECTION.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effectOctober 1, 2008.
