## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Somerset County – County Roads Board – Authority to Sell County Roads**

3 FOR the purpose of authorizing the County Roads Board of Somerset County to sell  
4 any county road in Somerset County without public sale and when the property  
5 is no longer needed for public use; providing that the County Roads Board may  
6 arrange the terms, conditions, and amount of consideration for and execute and  
7 acknowledge any deeds or instruments necessary to complete any sale made in  
8 accordance with this Act; and generally relating to the sale of public county  
9 roads in Somerset County.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

2   **AND TO ANY COUNTY ROAD;**

3                   (2)    **EXERCISE THE AUTHORITY UNDER ITEM (1) OF THIS SECTION:**

4                            (I)    **WITHOUT PUBLIC SALE; AND**

5                            (II)   **WHEN THE COUNTY ROAD IS NO LONGER NEEDED FOR**  
6   **PUBLIC USE;**

7                   (3)    **ARRANGE THE TERMS, CONDITIONS, AND AMOUNT OF**  
8   **CONSIDERATION, IF ANY, FOR ANY SALE MADE UNDER ITEM (1) OF THIS**  
9   **SECTION; AND**

10                   (4)   **EXECUTE AND ACKNOWLEDGE ANY DEEDS OR INSTRUMENTS**  
11   **NECESSARY TO COMPLETE ANY SALE MADE IN ACCORDANCE WITH ITEM (1) OF**  
12   **THIS SECTION.**

13           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
14   October 1, 2008.
