A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loans of 2006 and 2007 – Prince**
3 **George’s County – Historic Laurel Mill Ruins**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loans of 2006
5 and 2007 to remove the Patuxent River Commission as a grantee from certain
6 grants; and generally relating to the Historic Laurel Mill Ruins.

1 **Chapter 488 of the Acts of 2007**

2 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
3 MARYLAND, That:

4 (3) ZA02 LOCAL SENATE INITIATIVES

5 (BO) Historic Laurel Mill Ruins. Provide a grant of \$100,000, to
6 [the Patuxent River Commission and] the Mayor and City
7 Council of the City of Laurel for the repair, stabilization, and
8 reconstruction of the Historic Laurel Mill Ruins, located in
9 Laurel (Prince George’s County) 100,000

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
11 June 1, 2008.
