A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loans of 2005 and 2006 – Baltimore**
3 **City – Waxter Center for Senior Citizens**

5 and 2006 to expand the authorized uses of a certain grant to the Mayor and City
6 Council of the City of Baltimore.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

21 the matching fund provided, to the Mayor and City

23 renovation, reconstruction, [and] capital equipping,
24 **AND NEW CONSTRUCTION** of the Waxter Center for

6 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
7 MARYLAND, That:

9 (K) Waxter Center for Senior Citizens. Provide a grant
 10 equal to the lesser of (i) \$250,000 or (ii) the amount of
 11 the matching fund provided, to the Mayor and City
 12 Council of the City of Baltimore for the repair,
 13 renovation, reconstruction, [and] capital equipping,
 14 **AND NEW CONSTRUCTION** of the Waxter Center for
 15 Senior Citizens, located in Baltimore City.
 16 Notwithstanding Section 1(5) of this Act, the
 17 matching fund may consist of funds expended prior to
 18 the effective date of this Act (Baltimore City)..... 250,000

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
20 June 1, 2008.
