(2) An officer of a law enforcement agency who knowingly discloses a
report to a person not entitled to access the report under this section is guilty of a
felony and on conviction is subject to a fine not exceeding \$10,000 or imprisonment not
exceeding 15 years or both.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2008.
