## A BILL ENTITLED

1 AN ACT concerning

2 **Montgomery County - Mercy Health Clinic Loan of 2005**

3 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2005  
4 to alter the authorized uses of a certain grant and change a certain grantee to  
5 the Board of Directors of the Muslim Community Center, Inc.; permitting the  
6 grantee to include real property, in-kind contributions, and funds expended  
7 prior to the effective date of this Act in the matching fund; extending the  
8 deadline by which a certain grantee may present evidence to the Board of Public  
9 Works that a matching fund will be provided.

10 BY repealing and reenacting, with amendments,  
11 Chapter 445 of the Acts of the General Assembly of 2005  
12 Section 1(3) Items ZA01(AP) and ZA02(AU)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
14 MARYLAND, That the Laws of Maryland read as follows:
